#### 1. ORGANISER

The organiser of the competition is the German Boxing Association (DBV), which is the only state-recognized governing body for Olympic boxing in Germany. Through numerous national and international events – such as the long-standing Brandenburg Cup – the DBV has helped shape the careers of many successful athletes and Olympic medalists.

#### 2. SPORTS AND TRAINING FACILITIES

The championship will take place at the Olympic and Paralympic Training Center Kienbaum, located just outside Berlin in a quiet and forested area ideal for high-performance sport. The competition will be held in one of the center's main sports halls, which offers ample space to accommodate two competition rings. Temporary spectator stands and additional infrastructure will be installed to create a professional and athlete-friendly competition environment.

A second hall of similar size within the same complex will serve as the official training venue. Fully equipped training facilities – including boxing rings, strength and conditioning areas, and recovery zones – are available on site and will be accessible to all participants throughout the duration of the Championships. All facilities are located within walking distance of the athlete accommodations, ensuring optimal conditions for preparation and recovery.

#### 3. ABOUT THE COMPETITION

This is the very first U17 Men's & Women's European Boxing Championships newly established European Confederation of World Boxing.

U17 EUROPEAN BOXING CHAMPIONSHIP will be conducted according to the rules of WORLD BOXING. Two competition rings will be used during Preliminary Rounds till the Semifinals. There will be one competition ring used during the Finals.

#### 6. ENTRY PROCESS

It is required that respective participating National Federations confirm the technical and medical standard of the boxers and other Team Members. Participating National Federations are also responsible for submitting the personal data on behalf of each member of their Team, and for ensuring that the personal information provided during the entry process is accurate.

National Federation shall submit electronically personal data and current photographs of boxers and other team members which will be used for accreditations and promotional purposes. There are 3 phases of the entry process:







The normal application (phase 1), stating the number of participants in each weight category and requested accommodation Hotel name and category and number of the rooms to be sent by the National Federation latest by 18.09.2025.

The late application (phase 2) stating the number of participants in each weight category and requested accommodation Hotel name and category and number of the rooms to be sent by the National Federation latest by 08.10.2025.

The final application (phase 3) will contain full information about the participants nominated by the National Federations and must be submitted latest on **08.11.2025**.

Deposits will not be refunded after the application deadline.

It is mandatory for all participating National Federations with three or more participating boxers to register a World Boxing certified Referee and Judge as a part of their Team. Referee and Judges are subject to confirmation by European Boxing. European Boxing may request that another R&J should be registered for this event by the participating National Federation. Participating National Federations that fail to register an appropriately certified R&J for a Team with three or more boxers will be subject to a EUR 500 penalty. This penalty must be paid prior to the Sport Entries Check to European Boxing. The National Federation will be responsible to cover the costs for their registered and from European Boxing approved R&J.

They will be accommodated in separate hotel in twin or single rooms. Participating federations are responsible for travel costs to the city of Kienbaum or Berlin Airport and pay the accommodation 1200 EUR in twin room (single room on request). R&J's must have valid health insurance for the stay in Germany.

#### 7. ACCOPANYING TEAMMEMBERS-STAFF

Total number of accompanying teams that can be accredited per national Federation depends on the number of boxers competing.

Each team delegation may include the following accredited accompanying teams:

- 1 Team Leader
- 1 Team Doctor
- 1 Physio
- 1 Nutritionist

1 – 3 Boxers: max 3 Coaches
4 – 8 Boxers: max 6 Coaches
9 - 26 Boxers: max 8 Coaches

It is the responsibility of the participating National Federations to ensure that all team members are qualified to perform their duties.

The Team Doctor may be appointed by Technical Delegate to take part at the Weight-in. In case of conflict of interest the neutral Ringside doctor should be used.

#### 8. SPORTS ENTRIES CHECK

Sport Entries check is the final part of the event entry process and it will take place at Headquarter of the Sport Center Kienbaum on 09.12.2025 from 09:00 till 15:00. Sport Entries check is mandatory for all participating Teams should make all necessary arrangements to arrive on time for the relevant date.







Each team may nominate a maximum of two persons to attend their sports entry check (e.g. Team Leader and team doctor).

In order to be permitted to participate in the competition, teams must provide the following documents for each boxer, signed and completed as required:

- Copy of passport
- Boxer's Record Book (with annual medical examination carried out in the previous 12 months)
- Medical certificate issued in the last three months, signed by a doctor recognised by the NF
- Declaration of non-pregnancy (womens boxers only), signed by the boxer and legal representative
- Boxing Uniforms (red and blue) according to WORLD BOXING rules

To complete the Sport Entries process and receive accreditations, Teams must have fully settled their accommodation costs with the LOC.

Important: Failure to attend the Sport Entries Check per scheduled appointment by any Team will lead to the exclusion of the entire Team from taking part in the event with all accommodation and fees payable to the LOC forfeit.

#### 9. VISA AND ENTRY TO THE HOST COUNTRY

LOC will provide assistance to participating Teams requiring Visas but cannot guarantee their acquisition. Countries in whose citizens need of a visa to enter Germany must register their visa application in the e-consulate system. Please inform the LOC to issue the support letters as soon as possible.

Note: The file should be in Word/excel format.

The deadline for submitting applications for visa support letters is 08th October 2025.

Passports of all Championship participants must be valid for at least six months from the date of arrival and must include a blank page for visa and stamps.







#### 10. INTERNATIONAL TRANSPORTATION

There is one official airport for the arrival and departure of the teams. Berlin Brandenburg Airport (BER) in Germany.

LOC will provide complimentary transportation from the official airport on the day of arrival 08.12.2025 and on the day of departure on 18.12.2025.

All teams must send their arrival and departure information to the tournament organizer at event@boxverband.de by 08.11.2025 (CET 23:59).

#### 11. GROUND TRANSPORTATION

The organizer will arrange regular transport between the official hotels outside of Kienbaum and the competition venue. For other hotels, transport to the competition venue will not be provided.

In the event that airport transfers or other transport is required outside the days of the event, additional transport costs will be charged and will be quoted on request.

Event information and timings will be posted on the event website and social media and on a jointly created event communication channel.

#### 12. ACCOMMODATION / HOTELS

Participating teams must book accommodation at the event hotels through the organizing committee (not directly at the hotel).

All teams must send their accommodation request and room list to the tournament organizer at event@boxverband.de by the above dates.







#### IMPORTAN NOTICE

All accommodation will be released by the organiser after the closing date for Preliminary Phase entries and may not be available for countries that have not yet made a reservation. It is important to note that all countries will be bound by room reservations that they make at the time of the Preliminary Phase application deadline. We recommend that you book the minimum number of rooms required and if the number of boxers changes after the closing date for final entry Phase, contact the Organising Committee for any required increase in numbers.

All other costs (minibar, laundry, parking, etc.) and damages to hotel property resulting from the team's stay will be charged to the respective national federation and must be paid in full. Delegations are kindly requested not to dry clothes or practice in the corridors of the hotels.

Only accredited participants of the event will be allowed to stay in hotels.

The price includes accommodation, 3 meals per day, 1 liter bottle of still water per day and person and transport as per points 10 and 11.

All meals for registered participants will be served at the Sport Center Kienbaum. Delegations outside of the Sport Center Kienbaum will have breakfast and dinner at their respective hotels.

In case of early arrival at the event and early check in at accommodation, this should be communicated in advance by email to the LOC.

#### Hotels - 08. - 18.12.2025

The package includes: accommodation, three buffet meals a day, transport from Berlin-Brandenburg airport on the opening and closing days of the event, and ground transportations from/to the official hotels outside of the Sport Center Kienbaum to the competition venue.

There are 3 hotels to choose from. Please note there is limited availability at each hotel. LOC will use first come (reserve) first serve (confirm) basis for the hotel allocation.



#### 13. PAYMENT TERMS

All teams must cover their accommodation costs for the entire event period. Accreditations will not be issued until accommodation is paid in full to LOC.

Payment by bank transfer is accepted and a deposit of 50% is due by 18.09.2025 / Phase 1 or 08.10.2025 / Phase 2

The remaining balance must be paid in full by 08.11.2025 at the latest.

All payments must be received in euros.

## 14. RIGHTS TO AQUIRE TRANSMISSION RIGHTS AND VIDEO RECORDING

The organizing committee will film the event for broadcast, promotional videos and official event photographers will take still images of the boxers before and during the event. All training sessions will be open to accredited media unless the team specifically requests otherwise. By participating in the event, each team member agrees to grant their screen rights World Boxing, European Boxing and the Local organising committee.

Videotaping of bouts for any broadcast purposes (including social media) will not be permitted.

National Federations are only allowed to record their boxers' bouts with one camera per competition ring, as long as they are for technical purposes. A special place will be reserved at the venue for this purpose. Each national federation must present a signed copy of the Disclaimer to the manager of the world European boxing competition at the technical meeting for the video recording.







#### 15. MEDICAL SERVICES

The Organising Committee will provide first aid throughout the event to any participant who sustains a sports injury during competition ring the event. All the participants must have valid health insurance in Germany for the entire stay.

#### 16. ANTI-DOPING-MEASURES

Doping control will be conducted in accordance with World Boxing Anti-Doping Rules and World Anti-Doping Code. According to WADA regulations, blood testing and gender tests may be conducted before, during and after the competitions.

#### 17. INSURANCE

All accredited participants must have their own travel, health, repatriation and liability insurance that covers the entire event and travel period.
